Descripción del estado de conservación:

La pieza se encuentra en regular estado de conservación.
Se observa superficial y adherida.
Presenta decoloración en toda la pieza
Se observa deformación del objeto producto de la sequedad.
Posee faltante en la parte posterior izquierda, en la cubierta y en la zona frontal.
Presenta faltantes en el cuero que se usó como hilo para coser la pieza.
Se observan manchas de pintura en la superficie, zona frontal y base.
Presenta rayaduras leves en el interior y exterior de la pieza.

- Tratamiento realizado:

- Limpieza con brocha por arrastre por toda la pieza y aspirado suave.
